- 1) Upon approval of this application, My Produce Guy, in its sole discretion shall have the right to terminate the Applicant's credit privileges under this application at any time without prior notice, except as otherwise provided by law.

If any amount is not paid within said period, a delinquency charge of 1-1/2 % per month of the delinquent balance shall be added to the sum due. The undersigned purchaser also agrees to pay My Produce Guy a service charge of \$30.00 or 5% of the face value whichever is greater for all protested items (Checks or ACH's) not honored by the bank for any reason.
- 3) The undersigned purchaser agrees to pay; in the event the account becomes delinquent and is turned over to an attorney, attorney fees equal to 15 % of the principal and interest.
- 4) The undersigned purchaser agrees to notify My Produce Guy by certified mail or an overnight delivery service of any change in ownership of the customer and further agrees to be liable for all purchases should the undersigned fail to comply with said notification. In the event that this application is executed by more than one person, then, in such event the liabilities and obligations of the undersigned hereunder shall be joint and several and the relative words herein shall be read as plural.
- 5) Applicant expressly agrees the My Produce Guy shall not be responsible for any product nonconformity as to quantity, quality or price unless noted on the original delivery receipt at the time of delivery or unless My Produce Guy receives written notification by facsimile or otherwise of such nonconformity within 24 hours of delivery.
